## HVPE ESTIMATED NAV PER SHARE UPDATE AT 31 DECEMBER 2023

- **Estimated NAV per share of \$50.04 (£39.31); up 0.4% in US dollar terms over the month**
  - **7% of Investment Portfolio valued at 31 December 2023 (representing the public companies in the portfolio)**
  - **93% valued at 30 September 2023**
- **A net \$6 million invested in December 2023**

HarbourVest Global Private Equity Limited (“HVPE” or the “Company”), a FTSE 250 investment company with global exposure to private companies, managed by HarbourVest Partners, today announces its estimated Net Asset Value (“NAV”) at 31 December 2023.

HVPE provides a complete private equity solution for public investors, managing the portfolio through four phases of the private equity cycle to create value: Commitments, Investment, Growth, and Realisation.

### **Commitments**

During December 2023, HVPE made one new commitment to a global continuation solutions fund. The Company’s Investment Pipeline (unfunded commitments) decreased by \$43 million from the prior month, following capital called for investments, as highlighted below, and foreign exchange movements. The Investment Pipeline totalled \$2.5 billion at 31 December 2023.

### **Investment**

During December 2023, HVPE invested \$76 million into HarbourVest funds (compared to \$40 million in November 2023). The largest individual investment during the month was made to a 2022 vintage global secondary fund.

### **Growth**

At 31 December 2023, HVPE’s estimated NAV per share was \$50.04 (£39.31), compared to the 30 November 2023 estimate of \$49.83 (£39.48). This represents a 0.4% increase in US dollar terms over the previous month and was mainly driven by favourable foreign exchange movements.

The valuation breakdown of the HVPE portfolio as reported here is as follows: 7% as at 31 December 2023 (representing the public companies in the portfolio), and 93% actual 30 September 2023. Consistent with previous estimated NAV reports, valuations are also adjusted for foreign exchange movements, cash flows, and any known material events to 31 December 2023. This compares to 7% actual 30 November 2023 (representing the public companies in the portfolio), 81% actual 30 September 2023 and 12% actual 30 June 2023, used in the 30 November 2023 estimated NAV per share calculation.
